# Animal nutrition: undesirable substances and products. Codification

1995/0299(CNS) - 27/11/2001 - Implementing legislative act

PURPOSE: to set maximum levels for dioxins and furans in animal nutrition. COMMUNITY MEASURE: Council Directive 2001/102/EC amending Directive 1999/29/EC on the undesirable substances and products on animal nutrition. CONTENT: Maximum levels for dioxins and dioxin like PCBs is an appropriate tool for preventing unacceptably high exposure of animals and to prevent the distribution of feedingstuffs with an unacceptably high level of contamination. The setting of maximum levels is indispensable for the implementation of a regulatory control system and to ensure uniform application. For the time being maximum levels are not set for dioxin-like PCBs, given the very limited data available on the prevalence of the latter, but this will be reviewed by 31 December 2004. The Annex to this Directive sets the maximum levels for dioxins and furans, and provides that the levels will be further reviewed by 31 December 2006 with the aim of significantly reducing the maximum levels. DATE FOR TRANSPOSITION: 1 July 2002. ENTRY INTO FORCE: 10 January 2002.

# Animal nutrition: undesirable substances and products. Codification

1995/0299(CNS) - 06/12/1995 - Legislative proposal

OBJECTIVE: the purpose of the Commission proposal is to undertake codification of Council Directive 74/63/EEC of 17 December 1973 on the undesirable substances and products in animal nutrition. The new directive will supersede the various directives incorporated in it; their content is fully preserved, and they are brought together with only such formal amendments as are required by the codification exercise itself. This codified text will be used as the basis for the further development of legislation in this field.

PURPOSE: to codify directive 74/63/EEC on the undesirable substances and products in animal nutrition. The new directive replaces the various directives which are the subject of this codification. ENTRY INTO FORCE: 04/05/1999.

This is a consolidated version of the initial text also incorporating amendments purely of form or wording by the Consultative Working Party of Legal Services set up under the Interinstitutional Agreement of 20 December 1994 on an accelerated working method for official consolidation of legislative texts.

# Animal nutrition: undesirable substances and products. Codification

### 1995/0299(CNS) - 28/08/2001 - Document attached to the procedure

This document sets out the proposal for a Directive amending Council Directive 1999/29/EC on the undesirable substances and products in animal nutrition which is part of an overall strategy to reduce the presence of dioxins, furans and PCBs in environment, food and feed. Its purpose is to establish maximum limits for dioxins and furans in several feed materials and feedingstuffs. The proposed measures concerning feedingstuffs consist of three pillars: - firstly, the establishment of maximum levels, taking into account the current background contamination, at a strict but feasible level; - secondly, the establishment of action levels acting as a tool for 'early warning' which triggers a proactive approach from competent authorities and operators to identify sources and pathways of contamination and to take measures to eliminate them; - thirdly, the establishment of target levels, which are the levels to be achieved in order to bring the exposure of the large majority of the European population below the tolerable weekly intake set by the SCF.
