Oil and fibre plants: marketing of seed (codif. direct. 62/208/EEC)

1995/0304(CNS) - 28/06/2001 - Amended legislative proposal for reconsideration

Taking into consideration the legislative amendments which have been introduced to Directive 69/208/EEC since the initial proposal and the amended proposal for codification of the Commission from 1998 as well as the results of the work which took place within the Council, the Commission has decided to present a second amended proposal for codification of the Directive in question.

Oil and fibre plants: marketing of seed (codif. direct. 62/208/EEC)

1995/0304(CNS) - 13/06/2002 - Final act

PURPOSE : to consolidate Directive 69/208/EEC on the marketing of seed oil and fibre plants. COMMUNITY MEASURE : Council Directive 2002/57/EC on the marketing of seed oil and fibre plants. CONTENT : for reasons of clarity and rationality, this Directive aims to consolidate Directive 69/208/EEC, modified on several occasions since its adoption. The new directive replaces the various directives which are the subject of the codification procedure. It respects the substance of the codified texts completely and is restricted to gathering them in a single text while making only formal amendments required by the procedure of codification. ENTRY INTO FORCE : 9 August, 2002.

Oil and fibre plants: marketing of seed (codif. direct. 62/208/EEC)

1995/0304(CNS) - 11/12/1995 - Legislative proposal

OBJECTIVE: The proposed consolidated version of Council Directive 69/208/EEC of 30 June 1969 on the marketing of seed of oil and fibre plants forms part of a much larger programme of consolidation on the provisions on seeds and propagating material for agriculture, horticulture and forestry. It aims at consolidating the various directives incorporated in it; their content is fully preserved, and they are brought together with only such formal amendments as are required by the codification exercise itself. This codified text will serve as the basis for future legislative development in this field.

Oil and fibre plants: marketing of seed (codif. direct. 62/208/EEC)

1995/0304(CNS) - 28/09/1998 - Modified legislative proposal

This amended proposal aims to take account of the legislative changes since the initial proposal for codification of Directive 69/208/EEC on the marketing of seed of oil and fibre plants was presented and of the outcome of the Council's work on this proposal. This amended proposal also takes account of amendments purely of form or wording by the Consultative Working Party of Legal Services set up under the Interinstitutional Agreement of 20 December 1994 on an accelerated working method for official consolidation of legislative texts, where these are considered justified.
