## **Agricultural prices 1996/1997: basic prices and buying-in prices applicable in the fruit and vegetables sector**

1996/0072(CNS) - 26/06/1996 - Final act

1996/97 agricultural prices - fruit and vegetables. The Council adopted Regulation 96/1190/EC, fixing the basic prices and buying-in prices applicable in the fruit and vegetables sector. Pending adoption of the reform of the common organization of the markets in fruit and vegetables on the one hand, and of products processed from fruit and vegetables on the other, this regulation provides for the maintenance at current levels of the basic prices and buying-in prices applicable in the fruit and vegetables sector for the 1996-97 marketing year.

In adopting the report by Mr Giacomo SANTINI (UPE, I), the European Parliament approved the Commission proposal without amendments.

The Council adopted the Regulation on 26 June 1996, in anticipation of a general agreement on a prices package and in order to avoid the risk of a legal vacuum affecting those products whose season commenced on 1 July 1996.

Agricultural prices 1996/97 - Fruit and vegetables Pending a decision from the Council on the reform of the common organization of the markets in fresh and in processed fruit and vegetables, the Commission proposes to maintain the basic prices and buying-in prices for the 1996/97 marketing year at their current levels. It will draw conclusions from any over-runs of the intervention thresholds when the total withdrawals during the 1995/96 marketing year are known.
