Premium to sheep producers in non less-favoured areas of Ireland and Northern Ireland

1996/0102(CNS) - 23/07/1996 - Final act

OBJECTIVE: granting an additional premium to sheepmeat producers in non-less-favoured areas in Ireland and Northern Ireland in respect of Northern Ireland in order to offset a substantial loss of income incurred by these producers in Spring 1995 on account of market prices which were extremely low for the time of year. COMMUNITY MEASURE: Council Regulation (EC) 96/1452. SUBSTANCE: A supplementary premium of ECU 6.50 per ewe is granted for the 1995 marketing year to the affected Ireland and United Kingdom producers in respect of Northern Ireland. ENTRY INTO FORCE: 29 July 1996.

Premium to sheep producers in non less-favoured areas of Ireland and Northern Ireland

1996/0102(CNS) - 15/04/1996 - Legislative proposal

OBJECTIVE: to grant a supplementary premium payable to sheep producers in non-less favoured areas of Ireland and Northern Ireland to compensate for a significant loss of revenue suffered by producers in spring 1995 as a result of extremely low market prices for that period. SUBSTANCE: the Commission proposes the adoption of a separate regulation fixing a supplementary premium of Ecu 6.5 per ewe limited to the producers concerned and to the 1995 marketing year. The financial consequences for the 1996 budget are further expenditure of Ecu 9.5 million.
