## Human consumption: fruit jams, jellies, marmalades and chestnut purée

1996/0118(CNS) - 31/10/1996 - Economic and Social Committee: opinion, report

Subject to a number of comments, the Committee approves the Commission's proposals. It believes that they simplify existing directives on the products in question, and make them less prescriptive. The Committee also acknowledges the Commission's concentration on horizontal measures to protect consumers and the environment. The ESC believes that all references to the various additives should be omitted from the draft directives, since they are now regulated by the Directives on additives, sweeteners and colours. Instead, in each directive for foods where additives are permitted, there would be a separate article with a cross-reference to the three additive directives. The Committee considers the proposed implementation dates throughout to be unrealistically short. Given the time required nowadays for finalizing directives and the time taken by Member States for national implementation, they should all be revised. With reference to languages, the Committee points out that in several cases the proposal prescribes product names which are not those used by all consumers in a particular language. Normal consumer usage should be permitted throughout, and the Austrian terms must be added throughout.

## Human consumption: fruit jams, jellies, marmalades and chestnut purée

1996/0118(CNS) - 14/01/1998 - Text adopted by Parliament, partial vote at 1st reading/single reading

After having voted to alter the legal basis (Article 100a rather than Article 43 of the EC Treaty) and adopted all the amendments proposed by the Committee on the Environment to the proposal concerning the simplification of the vertical directives on food, the European Parliament, in response to a request from Mr Paul LANNNOYE (Greens, B), postponed its vote on the legislative proposals. Mr LANNNOYE gave as grounds for his request for postponement the Commission's refusal to accept a large number of Parliament's amendments.

## Human consumption: fruit jams, jellies, marmalades and chestnut purée

1996/0118(CNS) - 17/04/1996 - Legislative proposal

OBJECTIVE: pursuant to the undertakings given by the Community, simplification of certain vertical Directives relating to food to take account only of the essential requirements to be met by the products they cover in order that those products may move freely within the internal market. SUBSTANCE: the proposal for a Council Directive relating to jams and chestnut purée adapts Directive 79/693/EEC to general legislation on foodstuffs and, in particular, legislation on colouring agents, sweeteners, and other authorized additives. The proposal defines 'extra marmalade', 'marmalade jelly' and 'extra marmalade jelly' to take account of new products on the market. Directive 79/693/EEC stipulates that the products covered must have a soluble dry matter content of not less than 60%, consisting primarily of sugars. However, Member States are authorized to use the designations reserved by the Directive for products with a soluble dry matter content of less than 60%. The label must bear the total sugar content in every case. In view of the differences between the manufacturing methods used in the individual Member States, the Commission feels that this issue can be settled by the Member States, provided the label indicates the total sugar content.

## Human consumption: fruit jams, jellies, marmalades and chestnut purée

1996/0118(CNS) - 20/12/2001 - Final act

PURPOSE : to establish rules on the production and marketing of jams and similar products. COMMUNITY MEASURE : Council Directive 2001/113 /EC relating to fruit jams, jellies and marmalades and sweetened chestnut puree intended for human consumption. CONTENT : This Directive lays down definitions and common rules governing composition, manufacturing specifications and labelling of the products concerned so as to ensure their free movement within the Community. The general food labelling rules laid down in Directive 2001/13/EC apply, subject to certain conditions which are specific to the products within the scope of the Directive. In order to take into account existing national traditions in the making of fruit jams and similar products, the existing national regulations authorising the marketing of such products with a reduced sugar content is maintained. Directive 79/693 /EEC is repealed with effect from 12 July 2003. DATE OF TRANSPOSITION : 12/07/03 ENTRY INTO FORCE : 12/01/02

## Human consumption: fruit jams, jellies, marmalades and chestnut purée

1996/0118(CNS) - 04/05/1999 - Text adopted by Parliament, 1st reading/single reading

Under consultation procedure, the European Parliament adopted the resolution by Paul A.A.J.G. Lannoye (V,BE), which approves the Commission proposal for a Council directive relating to fruit jams, jellies and marmalades and chestnut purée intended for human consumption, subject to those amendments adopted at the sitting of 14/01/98.
