## Transport of dangerous goods by road: type-approval of motor vehicles and trailers (amend. Directive 70/156/EEC)

1996/0267(COD) - 09/07/1997 - Economic and Social Committee: opinion, report

As the Council has now adopted more than thirty-six separate type-approval directives for category N vehicles, the time has come to add type-approval provisions for vehicles designed to transport dangerous goods, too. The Committee agrees with the objectives of the proposed directive, but would point to the absolute need to standardize the scope of ECE and EC provisions. The Committee would ask the European Commission, and particularly DG VII, to take appropriate steps to prevent the benefits of this directive, and of Directive 94/55/EEC as amended by Directive 96/86/EC, from being undermined by divergent construction specifications issued by the competent authorities or other organizations. It must be ensured that the scope of ECE and EC provisions can be regarded as equivalent.

## Transport of dangerous goods by road: type-approval of motor vehicles and trailers (amend. Directive 70/156/EEC)

1996/0267(COD) - 14/12/1998 - Final act

**OBJECTIVE:** to establish the technical requirements for motor vehicles and their trailers intended for the transport of dangerous goods by road and to achieve total harmonisation of the relevant technical provisions. **COMMUNITY MEASURE:** Directive 98/91/EC of the European Parliament and the Council amending Directive 70/156/EEC. **CONTENT:** the Directive lays down a series of requirements with a view to achieving total harmonisation of the relevant technical provisions for vehicles intended for the transport of dangerous goods by road. It contains special provisions for: - the design and construction of the base vehicle intended for the transport of dangerous goods by road and technical specifications regarding electrical equipment in compliance with Directive 94/55/EC, the braking system (e.g. ABS and endurance braking system), fire risk prevention, speed limitation and the body of the vehicle. The Directive adds to the list of specific directives which need to be adhered to in order to comply with the CE type-approval procedure introduced in Directive 70/156/EEC. Compliance with all the relevant technical requirements of the proposed Directive will ensure free circulation for the vehicles concerned within the internal market of the European Union. **ENTRY INTO FORCE:** 16 January 1999. **DEADLINE FOR TRANSPOSITION:** 01/01/2000.

## **Transport of dangerous goods by road: type-approval of motor vehicles and trailers (amend. Directive 70/156/EEC)**

1996/0267(COD) - 19/02/1998 - Text adopted by Parliament, 1st reading/single reading

Adopting the report by Mr Fernand le Rachinel (NI, F), Parliament approves the proposal which aims to amend Directive 70/156/EEC to establish a European type approval system for vehicles used for the transport of dangerous goods. Parliament calls for the Member States to comply with the directive within 12 months of its publication.

## **Transport of dangerous goods by road: type-approval of motor vehicles and trailers (amend. Directive 70/156/EEC)**

1996/0267(COD) - 20/10/1998 - Text adopted by Parliament, 2nd reading

Adopting without debate the recommendation for second reading by Mr Fernand Le Rachinel (NI,F), Parliament approved the common position on motor vehicles and their trailers intended for the transport of dangerous goods by road and amending Directive 70/156/EEC relating to the type approval of motor vehicles and their trailers.

## **Transport of dangerous goods by road: type-approval of motor vehicles and trailers (amend. Directive 70/156/EEC)**

1996/0267(COD) - 10/12/1996 - Legislative proposal

**OBJECTIVE :** the proposal for a European Parliament and Council Directive seeks to establish the technical requirements for motor vehicles and their trailers intended for the transport of dangerous goods by road. It will ensure that the technical conditions exist to ensure that the dangerous goods are safeguarded during their transport. **SUBSTANCE :** The proposal for a directive lays down a series of requirements (Article 100A of the EC Treaty) with a view to achieving total harmonization of the relevant technical provisions for vehicles intended for the transport of dangerous goods by road. The proposal for a directive is a companion to Directive 94/55/EC and lays down special provisions for: - the design and construction of the base vehicle intended for the transportation of dangerous goods, and - technical specifications regarding: electrical equipment, braking system (e.g. ABS and endurance braking system), fire risk prevention and speed limitation. Compliance with all the relevant technical requirements of this Directive will ensure free circulation for the vehicles concerned within the internal market of the EU. This new Directive will be based on optional harmonization. Member States may require that only the prescriptions of the EC separate Directive apply. Alternatively they may maintain national legislation on this matter in which case the manufacturer can choose one or other of these options. This Directive does not affect national or Community legislation addressing the use of such vehicles.

## **Transport of dangerous goods by road: type-approval of motor vehicles and trailers (amend. Directive 70/156/EEC)**

1996/0267(COD) - 29/06/1998 - Council position

The common position does not incorporate Parliament's amendment. The articles of the common position have been revised to bring them into line with the structure of other directives on motor vehicles recently adopted by the Council and Parliament. The definition of the ADR agreement at Article 2 has been deleted as there is no reference to that agreement in the other articles or annexes. A reference has, however, been included in the preamble to demonstrate the link between this directive and the agreement.

## **Transport of dangerous goods by road: type-approval of motor vehicles and trailers (amend. Directive 70/156/EEC)**

1996/0267(COD) - 04/06/1998 - Modified legislative proposal

The amended proposal incorporates Parliament's amendment calling for Member States to comply with the Directive within twelve months of its publication.

## **Transport of dangerous goods by road: type-approval of motor vehicles and trailers (amend. Directive 70/156/EEC)**

1996/0267(COD) - 13/07/1998 - Commission communication on Council's position

La Commission accepted the common position, which accorded with the initial intentions of its proposal. It considered that early adoption of the Directive would enable the full type approval procedure to be implemented and to operate, and would constitute an important step towards realisation of the single market in this sector.
