Collective redundancies

1996/0290(CNS) - 05/12/1997 - Amended legislative proposal for reconsultation

OBJECTIVE: To propose a new version of the official consolidation of Council Directive 75/129/EEC on the approximation of the laws of the Member States relating to collective redundancies. CONTENT: The new version of the consolidation of Directive 75/129/EEC preserves the entire substance of the consolidated texts and is confined to regrouping them and introducing the formal amendments required by the actual operation of consolidation. An initial version of this consolidated text had already been proposed on 29 November 1996 (COM(96)620) and had been the subject of a first consultation before the European Parliament on 13 May 1997. Having regard to the results of the Council's work on this proposal, the Commission is presenting, pursuant to Article 189A(2) of the Treaty, a new proposal for consolidation of the Directive in question. This 'amended' proposal again takes into account certain purely editorial or formal adaptations suggested by the Consultative Working Party of the legal services envisaged by the Interinstitutional Agreement of 20 December 1994 on an accelerated working method for official codification of legislative texts, which have proved to be well founded.

Collective redundancies

1996/0290(CNS) - 16/06/1998 - Text adopted by Parliament after reconsultation

The European Parliament approved the amended proposal for a codified directive on collective redundancies without debate (Rule 99 of the Rules of Procedure).

Collective redundancies

1996/0290(CNS) - 20/07/1998 - Final act

OBJECTIVE: To consolidate Council Directive 75/129/EEC on the approximation of the laws of the Member States relating to collective redundancies. COMMUNITY MEASURE: Council Directive 98/59/EC on the approximation of the laws of the Member States relating to collective redundancies. SUBSTANCE: The consolidation of directive 75/129/EEC entirely respects the substance of the consolidated texts; it simply puts them together, with such formal modifications as are required by the consolidation itself. The new consolidated directive repeals Directive 75/129/EEC and its amendment and Directive 92/56/EEC, which have been consolidated. ENTRY INTO FORCE: 01.09.1998.

Collective redundancies

1996/0290(CNS) - 13/05/1997 - Text adopted by Parliament, 1st reading/single reading

The European Parliament approved this codified version of a proposal concerning collective redundancies under Rule 99 of its internal Rules of Procedure (procedure without debate).

Collective redundancies

1996/0290(CNS) - 29/11/1996 - Legislative proposal

OBJECTIVE: the purpose of the proposal is to undertake the codification of Council Directive 75/129/EEC on the approximation of the laws of the Member States relating to collective redundancies. SUBSTANCE: the new directive will supersede the various directives incorporated in it; their content is fully preserved, and they are brought together with only such formal amendments as are required by the codification exercise itself.
