Rice and seeds: common organisation of the markets (COM)

1997/0218(CNS) - 20/01/1998 - Final act

OBJECTIVE: to modify Regulation (EC) no. 3072/95 on the common organization of the market in rice and Regulation (EEC) no. 2358/71 on the common organization of the market in seeds. COMMUNITY MEASURE: Council Regulation (EC) no. 192/98. CONTENTS: this modification, which follows on from the overall agreement on the 1997/98 price proposals, seeks to include rice seeds in the CMO of rice so that they are eligible for the payments introduced when the sector was reformed in order to compensate for the reduction in the intervention price, and to modify the CMO of seeds in order to introduce a mechanism to stabilise production of seed for each member state. ENTRY INTO FORCE: 30 January 1998.

1997/0218(CNS) - 03/09/1997 - Legislative proposal

OBJECTIVE: To amend Regulation (EC) No 3072/95 on the common organization of the market in rice and Regulation (EEC) No 2358/71 on the common organization of the market in seeds. SUBSTANCE: The amendments proposed by the Commission have the following aims: - to introduce rice seeds in the list of products eligible for compensatory payments as from the 1998/1999 marketing year; - to maintain the compensatory payments fixed up to the 1999/2000 marketing year and to extend them for the subsequent marketing years; - to ensure a balance in the rice seeds market by introducing a stabilization mechanism for seed production.
