Structural business statistics: inclusion of insurance sector

1997/0232(CNS) - 08/09/1997 - Legislative proposal

OBJECTIVE: the proposal for a Council Regulation aims at complementing Council Regulation (EC, Euratom) concerning structural business statistics with a detailed module for structural statistics in insurance. SUBSTANCE: the proposal seeks to require Member States to provide Eurostat with

comparable statistical data relating to the structure, activity, competitiveness and performance of businesses in the insurance sector at European level. It should be noted that it is Member States that are responsible for the data collection, not the Commission. The Regulation lays down the norms and standards necessary for producing comparable statistics within the Union.

Structural business statistics: inclusion of insurance sector

1997/0232(CNS) - 28/01/1998 - Economic and Social Committee: opinion, report

The efficient monitoring of the insurance sector will require the existence of accurate, reliable, regular, timely, harmonized and comparable statistical data. It therefore supports in principle the Commission's present proposals. However, the collection, compilation and transmission of this data imposes a double burden; firstly, on the enterprises which have to provide the raw data relating to their own activities and, secondly, on the national administrative authorities within each Member State, which are responsible for aggregating the data provided and transmitting it to Eurostat. The ESC therefore shares the concerns that have been expressed that these burdens should not be unnecessarily increased. The ESC approves the Commission's proposal for a regulation, with some reservations, but considers that it should be made the subject of a SLIM initiative project in order to determine whether the benefits are commensurate with the additional costs being imposed on enterprises and governmental administrations.

Structural business statistics: inclusion of insurance sector

1997/0232(CNS) - 16/02/1998 - Final act

OBJECTIVE: extension of the scope of Regulation (EC, Euratom) No 58/97 concerning structural business statistics for undertakings in the insurance sector. COMMUNITY MEASURE: Council Regulation (EC, Euratom) No 410/98 SUBSTANCE: Regulation (EC, Euratom) No 58/97 established a common framework for the collection, compilation, transmission and evaluation of Community statistics on the structure, activity, competitiveness and performance of businesses in the Community. A new annex extends to the insurance sector the obligation to provide comparable, complete and reliable statistics.
