EC/Hungaria Europe Agreement: adaptation of institutional aspects following the 1995 enlargement

PURPOSE : to adopt a Protocol concluding the European Agreement between the European Communities and Hungary, in order to take account of the accession of Austria, Finland and Sweden to the European Union. CONTENT : the Protocol aims to associate Austria, Sweden and Finland with the basic agreement signed in Brussels on 16.12.1991 between the Community and Hungary, which entered into force on 01.02.1994. Consequently, the texts established in the Finnish and Swedish languages shall be authentic in the same manner as the original texts.

This proposal for a Council and Commission decision relates to the conclusion of a Protocol on the adaptation of the institutional aspects of the EC /Hungary Europe Agreement to take into account the accession of Austria, Finland and Sweden to the European Union so as to ensure that it conforms to the Commission's 1997 Proposal relating to this subject.
