Rice: common organisation of the market COM, scheme for compensatory payment

1998/0140(CNS) - 23/04/1998 - Legislative proposal

OBJECTIVE: to amend Regulation (EC) No 3072/95 on the common organization of the market in rice as regards the application of the scheme for compensatory payments. SUBSTANCE: the proposal replaces Greece's national base area with two separate base areas covering the same total area. Any overrunning of the base area where rice growing is not traditional will have no impact on the amount of aid granted to producers in the base area favourable to rice growing.

1998/0140(CNS) - 28/09/1998 - Final act

OBJECTIVE: to amend Regulation 3072/95/EC on the common organisation of the market in rice with regard to the scheme for compensatory payment. COMMUNITY MEASURE: Council Regulation (EC) 2072/98. SUBSTANCE: The regulation aims to replace the national base area for Greece with two separate base areas covering the same total area, in order to maintain areas devoted to rice-growing in regions where there is no genuine possibility of alternative crops. ENTRY INTO FORCE: the regulation is applicable from 1.9.1998.

1998/0140(CNS) - 14/07/1998 - Text adopted by Parliament, 1st reading/single reading

Parliament approved the proposal (procedure without report).
