Marketing of compound feedingstuffs and circulation of feed materials

1998/0238(COD) - 16/12/1998 - Text adopted by Parliament, 1st reading/single reading

This was a procedure without report. The proposal was approved.

Marketing of compound feedingstuffs and circulation of feed materials

1998/0238(COD) - 15/11/1999 - Council position

The Council's common position accepts in substance the Commission's proposal by only bringing about some amendments, that the Commission is able to accept. These amendments further clarify the intention of the measure and strengthen it in the light of the BSE and dioxin crisis. The main amendments introduced by the Council aim essentially to : - harmonise the terminology used in Community legislation in force, in particular the replacement of the word "marketing" by "putting into circulation", which had been introduced in Community legislation in the last decade; - specify that the quality of compound feedingstuffs for animals depends also on the minimum storage life of additives contained in the feed material and requires that this is made clear to the end user; - introduce a distinction as regards the quality requirements for the feed materials that are put into circulation and those which are put to direct use in animal nutrition. It is provided that neither may represent a danger to animal or human health or to the environment; - guarantee the traceability of a wider range of feed materials than those covered by Directive 90/667/EEC.

Marketing of compound feedingstuffs and circulation of feed materials

1998/0238(COD) - 15/03/2000 - Text adopted by Parliament, 2nd reading

The European Parliament has approved the common position adopted by the Council with a view to adopting a European Parliament and Council Directive amending Directive 79/373/EC on the marketing of compound feedingstuffs and Directive 96/25/EC on the circulation of feed materials. (Codecision procedure, second reading).

Marketing of compound feedingstuffs and circulation of feed materials

1998/0238(COD) - 10/04/2000 - Final act

PURPOSE : to amend Directive 79/373/EEC on the marketing of compound feedingstuffs and 96/25/EC on the circulation of feed materials.
COMMUNITY MEASURE : Directive 2000/16/EC of the European and the Council amending Council Directive 79/373/EEC on the marketing of compound feedingstuffs and Council Directive 96/25/EC on the circulation of feed materials. **CONTENT :** this Directive amends directives 79/373/EEC and 96/25/EC in order to firstly harmonise the terminology used in Community legislation in force, in particular the inclusion of "putting into circulation" or "circulation" instead of "marketing". This term is defined as the holding of compound feedingstuffs for the purposes of sale, including offering for sale, or any other form of transfer, whether free or not, to third parties, and the sale and other forms of transfer themselves. In addition, the Directive specifies that the quality of compound feedingstuffs for animals depends on the minimum storage life of additives contained in the feed material and requires that this is made clear to the end user. With regard to Directive 96/25/EC, this Directive shall apply to the circulation and use of feed materials within the Community. Member States shall prescribe that feed materials may be put into circulation in the Community only if they are of sound, genuine and merchantable quality. They shall prescribe that, when put into circulation or used, feed materials must not represent any danger to animal or human health or to the environment and must not be put into circulation in a manner that is liable to mislead. Furthermore, the name or business and the address or registered place of business of the producing establishment, the approval number, the reference number of the batch or any other particulars which ensure that the feed material can be traced, where the establishment must be approved in accordance with: - Directive 90/667/EEC; - Community measures included on a list to be drawn up in accordance with the procedure set out in Article 13. In addition, a list of materials whose circulation or use for animal nutrition purposes is restricted or prohibited shall be drawn up in order to ensure their compliance with Article 3. Member States shall adopt and publish not later than 3 May 2001, the laws, regulations and administrative provisions necessary to comply with this Directive. They shall inform the Commission thereof forthwith. The provisions adopted shall at least apply from 3 November 2001. **ENTRY INTO FORCE :** 03.05.2000.

Marketing of compound feedingstuffs and circulation of feed materials

1998/0238(COD) - 08/12/1999 - Commission communication on Council's position

One of the most problematic issues for achieving a common position has been the legal basis (Article 100 A of the EC Treaty) of the proposal. The Commission had defended that this was the correct legal basis. With the entry into force of the Treaty of Amsterdam, the Council and the Commission agreed that the proposal should be based on Article 152 (4) of the EC Treaty. For the rest, the Council approved the substance of the Commission's proposal with only a few amendments to which the Commission could agree.

Marketing of compound feedingstuffs and circulation of feed materials

1998/0238(COD) - 13/07/1998 - Legislative proposal

OBJECTIVE: to amend Directive 79/373/EEC on the marketing of compound feeding stuffs and Directive 96/25/EC on the circulation of feed materials.
SUBSTANCE: Very often feed materials for animals are produced and used as such by livestock farmers without being put into circulation; they are not then subject to the rules introduced by Directive 96/25/EC. It is therefore proposed to extend the field of application of Directive 96/25/EC and to amend its title accordingly so that in future the Community rules will legally encompass not only the putting into circulation of feed materials but also their use. The amendment will have the effect that the principle that feed materials must be sound, genuine and of merchantable quality will apply in future to all products used as animal feed. It is also proposed to require that feed materials must not present a threat to the environment. With regard to the amendment to Directive 79/373/EEC, the proposed measures provide that the registration number must also be shown on the label or in the document accompanying compound feeding stuffs, as is required already in the case of the approval number.

Marketing of compound feedingstuffs and circulation of feed materials

1998/0238(COD) - 16/09/1999 - Text adopted by Parliament confirming position adopted at 1st reading

The European Parliament confirmed its first reading in the context of the codecision procedure of the text that it adopted on 16.12.1998 concerning this proposal for a directive.
