## **Maritime safety, prevention of pollution from ships**

2000/0237(COD) - 05/11/2002 - Final act

PURPOSE : to improve the implementation of Community legislation on maritime safety, the prevention of pollution from ships and shipboard living and working conditions. COMMUNITY MEASURE : Directive 2002/84/EC of the European Parliament and of the Council amending the Directives on maritime safety and the prevention of pollution from ships. CONTENT : this Directive is closely linked to Regulation 2099/2002/EC of the European Parliament and of the Council of 5 November 2002, establishing a Committee on Safe Seas and the Prevention of Pollution from Ships (COSS) centralises the tasks of the committees established under the pertinent Community legislation on maritime safety, the prevention of safety, prevention of pollution from ships and shipboard living and working conditions. The Regulation and the Directive have the same objectives. However, more specifically, the purpose of this Directive is to improve the implementation of Community legislation on maritime safety, the prevention of pollution from ships and shipboard living and working conditions: - by making reference to the COSS; - by accelerating the update and facilitating the amendment of such legislation in the light of developments in the international instruments applicable in the field of maritime safety, prevention of pollution from ships and shipboard living and working conditions, pursuant to Regulation 2099/2002/EC. ENTRY INTO FORCE : 29/11/2002. TRANSPOSITION : 23/11/2003.

## **Maritime safety, prevention of pollution from ships**

2000/0237(COD) - 13/02/2001 - Text adopted by Parliament, 1st reading/single reading

The European Parliament endorsed the report by Mr Emmanouil BAKOPOULOS (EUL/NGL, GR) on maritime safety. Amendments were adopted requesting that the new name of the Committee on Safe Seas be 'Committee on Safe Seas and the Prevention of Pollution from Ships'.

2000/0237(COD) - 27/12/2001 - Modified legislative proposal

The Commission broadly welcomes the proposed amendments presented to the Commission by Parliament following its first reading. The Commission agrees to adopt the text in order to make it consistent with other pertinent Community legislation in this field.

## **Maritime safety, prevention of pollution from ships**

2000/0237(COD) - 15/09/2000 - Legislative proposal

PURPOSE : to amend the Council Directives in force governing maritime safety, protection of the marine environment and shipboard living and working conditions (refer equally to COD/2000/0236). CONTENT : this proposal for a directive aims to amend the existing directives in the field of maritime safety in order to take account of the establishment of the committee on safe seas and to facilitate their subsequent updating.

2000/0237(COD) - 24/09/2002 - Text adopted by Parliament, 2nd reading

The European Parliament adopted the resolution drafted by Emmanouil BAKAPOULOS (EUL/NGL, Greece) and approved the Council's common position.

## **Maritime safety, prevention of pollution from ships**

2000/0237(COD) - 27/05/2002 - Council position

Following the same approach as in the common position concerning the Regulation (refer to COD/2000/0236), the Council has modified the description of the scope of the directives covered by the proposal to include the prevention of pollution from ships. It shares, however, the view expressed, by the Commission that the protection of the marine environment is covered by the environmental legislation and that reference to this area should there not be included. The Common position includes a few other modifications to the Commission proposals. The description of purpose of the Directive (Article 1) has been slightly modified in order to clarify the reference to the update of Community legislation and to align its wording with the corresponding provision in the Regulation. Finally, some purely technical amendments have been introduced in order to take account of the most recent Community maritime legislation.
