Food aid policy: management and support of food security

2001/0005(COD) - 23/07/2001 - Final act

PURPOSE : to amend Regulation 1292/96/EC on food-aid policy and food-aid management and special operations in support of food security in order to adapt articles III and IV of the new Convention on Food Aid. COMMUNITY MEASURE : Regulation 1726/2001/EC of the European Parliament and of the Council amending Article 21 of Council Regulation 1292/96/EC. CONTENT : the Community and its Member States take part in a number of international agreements relating to food-aid policy, food-aid management and special operations in support of food security, among them the food Aid Convention 1999 (approved by Decision 2000/421/EC of 13 June 2000). The Council, acting by qualified majority on a proposal from the Commission and after consulting the European Parliament, shall determine the Community share of the overall amount of aid, either in tonnes of wheat equivalent or in a contribution of both the Community and its Member States. ENTRY INTO FORCE : 01/09/2001.

Food aid policy: management and support of food security

2001/0005(COD) - 16/05/2001 - Text adopted by Parliament, 1st reading/single reading

The European Parliament approved, without report, the Commission proposal to amend a 1996 regulation on food aid to bring EU legislation into line with the 1999 Food Aid Convention providing that food aid can be donated in other products additional to cereals.

Food aid policy: management and support of food security

2001/0005(COD) - 11/01/2001 - Legislative proposal

PURPOSE: to present a proposal for a Council Regulation amending Article 21 of Council Regulation 1292/96/EC on food-aid policy and food-aid management and special operations of food security. CONTENT: The aim of this proposal is to amend Council Regulation 1292/96/EC of 27.06.1996 on food-aid and food-aid management and special operations in support of food security, in order to bring Article 21 of the Regulation into line with Article III of the new Food Aid Convention 1999 (approved by Council Decision 2000/421/EC of 13 June 2000). The proposed amendments to the Regulation are the following: - the Council, acting on the basis of qualified majority voting, shall determine the Community share of the overall amount of aid, either in tonnes of wheat equivalent or in value or in a combination of tonnage and value, laid down by the Food Aid Convention as the total contribution of both the Community and its Member States; - the Commission shall coordinate the operations of the Community and the Member States as regards the supply of cereals aid under the Food Convention and shall ensure that the total contribution by the Community and its Member States is at least as high as the quantities provided for in the said aid Convention.
