## **Euro: protection against counterfeiting, PERICLES programme 2002-2005, extension to States which have not adopted euro**

2001/0106(CNS) - 17/12/2001 - Final act

PURPOSE : to extend the effects of the Decision establishing an exchange, assistance and training programme for the protection of the euro against counterfeiting ('Pericles' programme) to the Member States which have not adopted the euro as the single currency. COMMUNITY MEASURE : Council Decision 2001/924/EC. CONTENT : this Decision stipulates that the application of Articles 1 to 13 of Decision 2001/923/EC shall be extended to those Member States which have not adopted the euro as their single currency. ENTRY INTO FORCE : 21.12.2001. It shall apply from 01.01.2002.

## **Euro: protection against counterfeiting, PERICLES programme 2002-2005, extension to States which have not adopted euro**

2001/0106(CNS) - 13/11/2001 - Text adopted by Parliament, 1st reading/single reading

Using the procedure without debate, the European Parliament adopted the report by Gerhard Schmid (PES, D) on extending the Pericles programme, which deals with the protection of the euro against counterfeiting, to Member States who have not adopted the euro as their single currency. The proposal was approved without amendments.
