Visas: exemption of visa requirement for Romanian nationals

2001/0231(CNS) - 08/10/2001 - Legislative proposal

PURPOSE: To remove visa derogations for Romanian nationals. **CONTENT:** Council Regulation No 539/2001 is a list of all third countries whose nationals must be in possession of visas when crossing the EU's external borders. Also listed in the Regulation are those nations whose nationals are exempt from that requirement. Romania is listed in Annex II of the Regulation thus exempting it from any visa requirements. However, there is an asterisk attached to Romania's entry in the Annex which effectively means that the application of a visa derogation to Romanian nationals is to be

decided by the Council at a later stage. The Commission is obliged to offer a report on the visa situation with Romania plus a list of recommendations. Following just such an evaluation the Commission recommends an amendment to Regulation 539/2001/EC allowing the derogation from visa requirements for Romanian nationals to take effect as from 1 January 2002. This corresponds to Parliamentary wishes as well as confirming the Commission's line in its initial proposal for a Regulation.

Visas: exemption of visa requirement for Romanian nationals

2001/0231(CNS) - 29/11/2001 - Text adopted by Parliament, 1st reading/single reading

The European Parliament approved the report for a proposal for a Council regulation amending Regulation 539/2001/EC listing the third countries whose nationals must be in possession of visas when crossing the external borders and those whose nationals are exempt from that requirement.

Visas: exemption of visa requirement for Romanian nationals

2001/0231(CNS) - 07/12/2001 - Final act

PURPOSE: To exempt Romania from visa obligations as from 1 January 2002. COMMUNITY MEASURE: Council Regulation 2414/2001/EC amending Regulation 539/2001/EC listing the third countries whose national must be in possession of visas when crossing the external borders of Member States and those whose nationals are exempt from that requirement. CONTENT: Romania, although listed in an annex under Regulation 539/2001/EEC (which would ordinarily have entitled it to visa derogations), was nevertheless subject to restriction concerning entry visas for its citizens. An asterisk next to its entry in the annex effectively meant the usual visa requirements were suspended. In June 2001 the Commission presented a report to the Council in which it recommended that these restrictions be lifted. Justification to do so was based on Commission findings which noted a marked improvement in Romania's illegal immigration policy, its visa policy and the controls at its borders. The United Kingdom and Ireland have decided not to participate in the application of this Regulation. Hence the provisions of this Directive will not apply to Ireland or to the United Kingdom. In order to enact the Commission recommendations Directive 539/2001 has been amended including the deletion of the asterisk next to Romania's entry, which effectively frees it of any visa obligations. ENTRY INTO FORCE: 1 January 2002.

Visas: exemption of visa requirement for Romanian nationals

2001/0231(CNS) - 07/12/2001

The Council endorsed the Mixed Committee's work on the lifting, with effect from 1 January 2002, of the visa requirement for Romanian nationals to cross EU borders, in line with the provisions relating to Romania in the Regulation listing the third countries whose nationals must be in possession of visas when crossing the external borders and those whose nationals are exempt from that requirement. The lifting of the visa requirement for Romanian nationals will be effective from the twentieth day following publication of the relevant Decision in the Official Journal.
