Structural Funds: Commission implementing powers

2001/0313(AVC) - 26/05/2003 - Final act

PURPOSE : amending Regulation 1260/1999/EC laying down general provisions on the Structural Funds. COMMUNITY MEASURE : Council Regulation 1105/2003/EC amending Regulation 1260/1999/EC laying down general provisions on the Structural Funds. CONTENT : the Council adopted a Regulation amending Regulation 1260/1999/EC laying down general provisions on the Structural Funds. The objective of this amendment is to bring into line the provisions of Regulation 1260/1999 relating to committees which assist the Commission in the exercise of its implementing powers, to the provisions of the Decision 1999/468 laying down the procedures for the exercise of implementing powers conferred on the Commission. ENTRY INTO FORCE : 27 June 2003.

Structural Funds: Commission implementing powers

2001/0313(AVC) - 30/07/2002 - Legislative proposal

In accordance with the joint statement of the Council and of the Commission on Decision 1999/468/EC, the provisions relating to committees which assist the Commission in the exercise of its implementing powers, provided for pursuant to Decision 87/373/EEC, should be adapted in order to bring them into line with the provisions of Articles 3,4 and 7 of Decision 1999/468/EC. Therefore Regulation 1260/1999/EC should be amended in order for it to conform to 1999/468/EC.

Structural Funds: Commission implementing powers

2001/0313(AVC) - 11/03/2003 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted a resolution drafted by Monica FRASSONI (Greens/ALE, Belgium) and gave its assent to the proposal on the general provisions on the Structural Funds.

Structural Funds: Commission implementing powers

2001/0313(AVC) - 27/12/2001 - Initial legislative proposal

PURPOSE : to adapt the provisions relating to committees which assist the Commission in the exercise of its implementing powers laid down in Council instruments adopted under the assent procedure. CONTENT : Council Decision 1999/468/EC of 28 June 1999 laying down the procedures for the exercise of implementing powers conferred on the Commission¹ repealed Decision 87/373/EEC of 13 July 1987 (refer to procedure reference CNS /1998/0219). Statement No 2 of the Council and of the Commission on Decision 1999/468/EC specifies that the Council and the Commission agree that the provisions relating to committees which assist the Commission in the exercise of its implementing powers, provided for in application of Decision 87/373/EEC, should be adapted in order to bring them into line with the provisions of Articles 3, 4 and 5 of Decision 1999/468/EC. The joint statement provides that procedures of type I, IIa, IIb, IIIa and IIIb should be automatically brought into line, whereas the amendment of the safeguard procedures should be done on a case-by-case basis. This proposed Regulation does not affect either the substantive provisions of the amended legislative acts or the application of the latter. This proposed Regulation, which aims to bring into line the legislative acts which establish the committees and the legislative acts which refer to these committees, does not affect the nature of the committees provided for by the basic act. It does not apply to the legislative acts which have already been brought into line by an act amending the basic act nor does it prejudice the Commission's proposals for legislative acts amending the basic act which have been submitted since 18 July 1999, the date of entry into force of Council Decision 1999/468/EC. It applies to legislative acts which are still in force when it enters into force.
