PURPOSE : to appoint Mr Morten Louis LEVYSOHN to the Court of Auditors. COMMUNITY MEASURE : Council Decision 2001/785/EC, ECSC, Euratom. CONTENT : Mr Morten Louis LEVYSOHN is appointed a member of the Court of Auditors for the period from 1 January 2002 to 28 February 2006.
