## Court of Auditors: appointment of Mr TOBISSON

2001/0816(CNS) - 28/06/2001 - Legislative proposal

PURPOSE : to consult the European Parliament on the partial renewal of the Members of the Court of Auditors. CONTENT : in accordance with Article 247 (3) paragraph 1 of the EC Treaty, the Council consults the European Parliament on the nomination of Mr Lars TOBISSON (Sweden) as a Member of the Court of Auditors following the resignation of another Member of the Court.

## Court of Auditors: appointment of Mr TOBISSON

2001/0816(CNS) - 08/11/2001 - Final act

PURPOSE : to appoint Mr Lars TOBISSON to the Court of Auditors. COMMUNITY MEASURE : Council Decision 2001/786/EC, ECSC, Euratom.  
CONTENT : Mr Lars TOBISSON is appointed a member of the Court of Auditors for the period from 1 January 2002 to 28 February 2006.
