# 2004 enlargement, Kaliningrad: uniform formats for Facilitated Transit Documents (FTD) and Facilitated Rail Transit Documents (FRTD)

2003/0027(CNS) - 14/04/2003 - Final act

PURPOSE: to establish the rules on uniform formats for Facilitated Transit Documents (FTD) and Facilitated Rail Transit Documents (FRTD) provided for in Regulation 693/2003/EC. COMMUNITY MEASURE: Council Regulation 694/2003/EC. CONTENT: Council Regulation 693/2003/EC established a FTD and FRTD for the case of specific transit by land of third country nationals who must necessarily cross the territory of one or several Member States in order to travel between two parts of their own country which are not geographically contiguous. This Regulation establishes uniform formats for these documents. The Commission will decide further technical specifications for the uniform format, such as additional security features and requirements including anti-forgery standards. The latter will be assisted by a Committee established by Article 6 of Regulation 1683/95/EC. These specifications will be secret and will not be published. They will be made available only to the bodies designated by the Member States as responsible or printing, and to duly authorised persons. The need for the incorporation of a photograph, which is referred to in the Annex, may be determined by the end of 2005. ENTRY INTO FORCE: 18/04/03.

2003/0027(CNS) - 05/02/2003 - Legislative proposal

PURPOSE: to establish uniform formats for the Facilitated Transit Document (FTD) and the Facilitated Rail Transit Document (FRTD). CONTENT: the Commission has proposed the adoption of a regulation establishing the FTD and FRTD for the case of a specific transit by land, allowing a third country national who needs to transit via the territory of one or several Member States to travel from one part of their country to another part of the same country. (See CNS/2003/0026). Uniform formats for these documents are proposed. These formats contain all the necessary information and meet high technical standards, particularly as regards safeguards against counterfeiting. The formats are suitable for use by all Member States and bear universally recognisable harmonised security features which are clearly visible to the naked eye. To ensure that information is not divulged more widely than is necessary, each Member State must designate a single body for printing the uniform format for FTD/FRTD. The body may be changed if necessary. For security reasons, each Member State must communicate the name of the competent body to other Member States and the Commission. This proposal constitutes a development of the Schengen acquis. Certain Member States will not be bound by its adoption.
