Road safety: two-wheel motor vehicles, passenger hand-holds (repeal. Directive 93/32/EEC). Codification

2003/0058(COD) - 13/07/2009 - Final act

PURPOSE: to codify Council Directive 93/32/EEC on passenger hand-holds on two-wheel motor vehicles.

LEGISLATIVE ACT: Directive 2009/79/EC of the European Parliament and of the Council on passenger hand-holds on two-wheel motor vehicles (Codified version).

CONTENT: the purpose of this directive is to codify Council Directive 93/32/EEC of 14 June 1993 on passenger hand-holds on two-wheel motor vehicles, which has been substantially amended. The Directive will supersede the various acts incorporated in it. It fully preserves the content of the

acts being codified and hence does no more than bring them together, with only such formal amendments as are required by the codification exercise itself.

ENTRY INTO FORCE: 21/08/2009.

APPLICATION: from 01/01/2010.

2003/0058(COD) - 02/06/2006 - Legislative proposal

To recall, on 27 March 2003, the Commission presented a proposal for a European Parliament and Council Directive codifying Council Directive 93/32/EEC of 14 June 1993 on passenger hand-holds on two-wheel motor vehicles. In its opinion of 26 June 2003 the Consultative Working Party of the legal services set up under the Interinstitutional Agreement of 20 December 1994 on an accelerated working method for official codification of legislative textshas stated that the above proposal does indeed confine itself to straightforward codification, without any substantive changes to the acts covered by it.

In view of the work already carried out in the Council on the proposal referred to at point 1, the Commission has decided to present – in accordance with Article 250 (2) of the EC Treaty – an amended proposal for codification of the Directive in question.

This amended proposal also takes account of the purely formal or editorial changes proposed by the Consultative Working Party of Legal Services, where these are considered justified. This amended proposal also includes corrigenda to Directive 93/32/EEC.

2003/0058(COD) - 27/03/2003 - Initial legislative proposal

PURPOSE : to undertake codification of Council Directive 93/32/EEC of 14 June 1993 on passenger hand-holds on two-wheel motor vehicles.

CONTENT : the new Directive will supersede the acts incorporated in it; this proposal fully preserves, the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself. The codification proposal was drawn up on the basis of a preliminary consolidation, in all official languages, of Directive 93/32/EEC and the instrument amending it, carried out by the Office for Official Publications of the European Communities, by means of a data-processing system. Where the Articles have been given new numbers, the correlation between the old and the new numbers is shown in a table contained in Annex III to the codified Directive.
