2004 enlargement: adapting the reference amounts of certain programmes

2003/0303(COD) - 09/03/2004 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted the resolution drafted by Reimer BÖGE (EPP-ED, D) and Joan COLOM I NAVAL (PES, Spain) approving the proposal. (Please see the document dated 17/02/04.) It stated that the amounts referred to in the legislative proposals are compatible with the ceiling of heading 3 of the financial perspective as adjusted and revised in order to take account of enlargement.

2003/0303(COD) - 10/12/2003 - Legislative proposal

PURPOSE : to amend the reference amounts - within the meaning of the Interinstitutional Agreement of 6 May 1999, Article 33 - of expenditure programmes adopted by the co-decision procedure, in order to take account of enlargement. **CONTENT** : when adapting the financial perspective for the period 2000-2006 in order to take account of enlargement, the European Parliament and the Council agreed the following statement agreed to revise (by the end of the budgetary procedure for 2004) in accordance with the co-decision procedure, the reference amounts of the co-decided programmes within the limits of the ceiling resulting from the above-mentioned adjustment and revision of the financial perspective. For all the co-decided programmes financed under heading 3 of the financial perspective (Internal Policies), it is therefore necessary to adapt the financial reference amounts included in each of the legislative acts concerned. The Commission, in the general introduction (volume 0) to the Preliminary Draft Budget, proposed new amounts for the reference amounts concerned, seeking a political agreement of the budgetary authority before submitting the corresponding legislative proposals. 2003/0303(COD) - 21/04/2004 - Final act

PURPOSE : to amend the reference amounts - within the meaning of the Interinstitutional Agreement of 6 May 1999, Article 33 - of expenditure programmes adopted by the co-decision procedure, in order to take account of enlargement. **LEGISLATIVE ACT** : Decision 786/2004/EC of the European Parliament and of the Council amending Decisions 1720/1999/EC, 253/2000/EC, 508/2000/EC, 1031/2000/EC, 1445/2000/EC, 163/2001/EC, 1411/2001/EC, 50/2002/EC, 466/2002/EC, 1145/2002/EC, 1513/2002/EC, 1786/2002/EC, 291/2003/EC and 20/2004/EC with a view to adapting the reference amounts to take account of the enlargement of the European Union. **CONTENT** : for all the co-decided programmes financed under heading 3 of the financial perspective (Internal Policies), this Regulation adapts the financial reference amounts included in each of the legislative acts concerned. The conciliation meeting of 24 November 2003 concluded on an agreement on adapted reference amounts (please refer to the summary dated 10/12/2003). **ENTRY INTO FORCE** : 30/04/2004.
