EC/Tunisia agreement: protocol to the Euro-Mediterranean agreement following the 2004 enlargement

2004/0265(AVC) - 06/09/2005 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted the resolution drafted by Elmar **BROK** (EPP-ED, DE) and gave its assent to the conclusion of the Protocol to the Agreement with Tunisia.

2004/0265(AVC) - 20/09/2005 - Final act

PURPOSE: The signature and conclusion of a Protocol between the EU and the Republic of Tunisia taking account of EU expansion.

LEGISLATIVE ACT: Council Decision 2005/720/EC on the conclusion of the Protocol to the Euro-Mediterranean Agreement establishing an association between the European Communities and their Member States, of the one part, and the Republic of Tunisia, of the other part, to take account of the accession of ten new EU Member States.

CONTENT: This decision permits the association of the 10 new Member States to the Euro-Mediterranean Agreement between the European Communities and their Member States, of the one part, and the Republic of Tunisia, of the other part. The protocol also adapts the protocol on agricultural products to the main Agreement and to include the new official languages of the Union in the text of the Agreement.

ENTRY INTO FORCE: the Protocol will enter into force once the formalities necessary for this to take place have been completed.

PURPOSE: The signature and conclusion of a Protocol between the EU and the Republic of Tunisia taking account of EU expansion.

PROPOSED ACT: Council Decision

CONTENT: The accession of the new EU Member States to the Euro-Mediterranean Association Agreement is to be agreed by means of a protocol to the Act of Accession. Negotiations between the EU and Tunisia regarding the Protocol have now been completed. The attached proposal is thus, for a Council Decision on the signature of the Protocol and a Council Decision on the conclusion of the Protocol. The most important aspects of the protocol are the provision for the accession of the new Member States to the EU-Tunisia Association Agreement, the adaptation of the Protocol on agricultural products and the inclusion of the new official languages of the EU.
