PURPOSE: amendment of Regulation 2500/2001/EC to enable the implementation of Community assistance for Turkey according to the new Financial Regulation.

LEGISLATIVE ACT: Council Regulation 850/2005/EC.

CONTENT: This amended Regulation brings Council Regulation 2500/2001/EC concerning pre accession financial assistance for Turkey in line with the new Financial Regulation as concerns the use of centralised indirect management (Art. 54 (2) (c) FR). In the area of pre-accession aid, centralised indirect management has proved a valuable tool in the past, in particular concerning the operations of the Technical Assistance and Information Exchange programme (TAIEX). Turkey has derived considerable benefit from TAIEX operations over recent years and this Regulation ensures that Turkey can continue to access TAIEX assistance between now and the entry into force of the IPA-Regulation under the conditions established by the new Financial Regulation.
