## EC/Morocco Euro-Mediterranean Association Agreement: 2004 enlargement of the EU. Protocol

2004/0292(AVC) - 06/09/2005 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted the resolution drafted by Elmar **BROK** (EPP-ED, DE) and gave its assent to conclusion of the Protocol to the Agreement with Morocco.

## EC/Morocco Euro-Mediterranean Association Agreement: 2004 enlargement of the EU. Protocol

2004/0292(AVC) - 10/06/2005 - Legislative proposal

PURPOSE : to include the 10 new Member States in the Euro-Mediterranean Agreement between the European Union and Morocco.

PROPOSED ACT : Council Decision.

CONTENT : according to the terms of Article 6(2) of the Act of Accession of the new EU Member States to the EU, accession of the new EU Member States to the Euro-Mediterranean Association

Agreement is to be agreed by means of a protocol to this Agreement. The same article provides for a simplified procedure, whereby the protocol is to be concluded by the Council, acting unanimously on behalf of the Member States, and by the third country concerned. This

procedure is without prejudice to the Community's own competences.

The most important aspects of the protocol are the provisions for the accession of the new Member States to the EU/Morocco Agreement, the inclusion of the new official languages of the EU and, above all, the adaptation of the concession made by Morocco on trade in agricultural products to take account of the EU's enlargement.

The text of the protocol negotiated with Morocco is attached (please refer to Council document 7002/2005).

## EC/Morocco Euro-Mediterranean Association Agreement: 2004 enlargement of the EU. Protocol

2004/0292(AVC) - 20/09/2005 - Final act

PURPOSE: To establish an association between the EU and Morocco through the Euro-Mediterranean Agreement, to include the ten new EU Member States.

LEGISLATIVE ACT: Council Decision 2005/695/EC on the conclusion of a Protocol to the Euro-Mediterranean Agreement establishing an association between the European Communities and their Member States, on the one part and the Kingdom of Morocco on the other, to take account of the ten new EU Member States.

CONTENT: This Decision establishes an association between the ten new EU Member States and the Kingdom of Morocco by means of the Euro-Mediterranean Agreement. The Protocol attached to the Decision contains certain changes relating mostly to agricultural provisions. For the rest the Protocol incorporates the new official languages of the EU into the text of the Agreement.

ENTRY INTO FORCE: The Protocol enters into force on the first day of the first month following the date of the deposit of the last instrument of approval. The provisions of the Protocol apply as from 1 May 2004.

## **EC/Morocco Euro-Mediterranean Association Agreement: 2004 enlargement of the EU. Protocol**

2004/0292(AVC) - 15/03/2005 - Supplementary legislative basic document

This document constitutes the final version of the protocol to the Agreement between the European Union and Morocco concerning the inclusion of the 10 new Member States to the Euro-Mediterranean Agreement between the Union and this country.
