Court of Auditors: appointment of Olavi Ala-Nissilä

2005/0809(CNS) - 23/01/2006

PURPOSE : to nominate a member of the Court of Auditors.

LEGISLATIVE ACT : Council Decision 2006/36/CE/Euratom appointing eight members of the Court of Auditors.

CONTENT : The Council has decided to nominate Mr **Olavi ALA-NISSILÄ** as a member of the Court of Auditors for the period from 1 March 2006 to 29 February 2012.

2005/0809(CNS) - 13/12/2005 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted a resolution drafted by José Javier **POMÉS RUIZ** (EPP-ED, ES) and delivered a favourable opinion on the appointment of Mr **Olavi ALA-NISSILÄ** (Finland) as a Member of the Court of Auditors. The appointment was approved by secret ballot by 519 votes in favour to 28 against with 60 abstentions.

2005/0809(CNS) - 14/10/2005 - Legislative proposal

PURPOSE: appointment of a member of the Court of Auditors

PROPOSED ACT: Council Decision

CONTENT: Under the first subparagraph of Article 247(3) of the Treaty establishing the European Community and the corresponding provisions of the EAEC Treaty, members of the Court of Auditors are appointed by the Council, acting by qualified majority after consulting with the European Parliament.

The Council has accordingly decided to consult the European Parliament on the appointment to the Court of Auditors of Mr Olavi ALA-NISSILA.
