2006/0071(COD) - 12/12/2006 - Final act

PURPOSE: to codify Council Directive 93/98/EEC.

LEGISLATIVE ACT: Directive 2006/116/EC of the European Parliament and of the Council on the term of protection of copyright and certain related rights (codified version).

CONTENT: the purpose of this proposal is to undertake a codification of Council Directive 93/98/EEC harmonising the term of protection of copyright and certain related rights. This is being done in accordance with EU provisions for the simplification and clarification of EU law given that Directive 93/98/EEC has been subject to numerous amendments.

The new Directive supersedes the various acts incorporated in it whilst fully preserving the content of the acts being codified. It does no more than bring them together with only such formal amendments as are required by the codification exercise itself.
