EC/Algeria agreement: protocol to the Euro-Mediterranean association Agreement following the 2004 enlargement

2006/0254(AVC) - 10/07/2007 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted the resolution by Jacek **SARYUSZ-WOLSKI** (EPP-ED, PL) approving the proposed Council Decision on the conclusion of the Protocol to the Euro-Mediterranean Agreement establishing an Association between the European Communities and Algeria to take account of the accession of the Czech Republic, Estonia, Cyprus, Hungary, Latvia, Lithuania, Malta, Poland, Slovenia and the Slovakia to the European Union.

EC/Algeria agreement: protocol to the Euro-Mediterranean association Agreement following the 2004 enlargement

2006/0254(AVC) - 06/12/2006 - Initial legislative proposal

PURPOSE: the signing and provisional application of a Protocol and the conclusion of a Protocol to the Euro-Mediterranean Agreement between the Community and Algeria to take account of EU enlargement.

PROPOSED ACT: Council Decision.

CONTENT: provisions set out in Article 6(2) of the Act of Accession, state that the ten new Member States, who acceded to the EU in May 2004, should also accede to the Euro-Mediterranean Association Agreement by use of a Protocol. In February 2004, the Council authorised the Commission to negotiate such a Protocol with People's Democratic Republic of Algeria. The negotiations have now been concluded.

The Protocol has been designed, primarily, to take account of EU enlargement to the EU-Algeria Association Agreement. The new Protocol also includes the new official languages of the EU.

EC/Algeria agreement: protocol to the Euro-Mediterranean association Agreement following the 2004 enlargement

2006/0254(AVC) - 12/04/2007 - Document attached to the procedure

This text takes into consideration a certain number of recent institutional developments within the European Union since the signature and the entry into force of the EU-Algeria Euro-Mediterranean Agreement (signed in Valencia on 22 April 2002 and entered into force on 1 September 2005).

The amendments concern the expiry of the Treaty establishing the European Coal and Steel Community, existing provisions in the Euro-Mediterranean Agreement referring to the European Coal and Steel Community shall be deemed to refer to the European Community, which has taken over all rights and obligations contracted by the European Coal and Steel Community.

The rest of the Agreement remains unchanged (see the summary dated 06/12/2006).

The Council adopted a decision on the signing and provisional application of a Protocol to the Euro-Mediterranean Agreement with Algeria to take account of the accession of ten new Member States to the EU in May 2004.

2006/0254(AVC) - 24/05/2007

The Council decided to forward to the European Parliament, for **its assent**, a draft decision on the conclusion of the Protocol to the EU-Algeria Association Agreement to take account of the accession of ten Member States to the EU in May 2004.

The Protocol to the EU-Algeria Association Agreement was signed on 24 April in Luxembourg.

2006/0254(AVC) - 15/05/2007 - Legislative proposal

This is the definitive version of the of the Protocol to the Euro-Mediterranean Agreement establishing an Association between the European Community and its Member States, of the one part, and the People's Democratic Republic of Algeria, of the other part, to take account of the accession of the Czech Republic, the Republic of Estonia, the Republic of Cyprus, the Republic of Hungary, the Republic of Latvia, the Republic of Lithuania, the Republic of Malta, the Republic of Poland, the Republic of Slovenia and the Slovak Republic to the European Union.

Overall, the text conforms to the previous version dated 12/04/2007.

2006/0254(AVC) - 23/07/2007 - Final act

PURPOSE: to conclude Protocol to the Euro-Mediterranean Agreement between the Community and Algeria to take account of EU enlargement.

PROPOSED ACT: Council Decision 2007/544/EC on the conclusion of the Protocol to the Euro-Mediterranean Agreement establishing an Association between the European Community and its Member States, of the one part, and Algeria, of the other part, to take account of the accession of the Czech Republic, Estonia, Cyprus, Latvia, Lithuania, Hungary, Malta, Poland, Slovenia and Slovakia to the European Union.

CONTENT: provisions set out in Article 6(2) of the Act of Accession, state that the ten new Member States, who acceded to the EU in May 2004, should also accede to the Euro-Mediterranean Association Agreement by use of a Protocol.

The Protocol has been designed, primarily, to take account of EU enlargement to the EU-Algeria Association Agreement. The new Protocol also includes the new official languages of the EU.

ENTRY INTO FORCE: 23 July 2007.
