2006/0812(CNS) - 12/12/2006 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted a resolution drafted by Szabolcs **FAZAKAS** (PES, HU) by 356 votes for, 229 against and 51 abstentions and delivered a favourable opinion on the nomination of Ovidiu **ISPIR** as a Member of the Court of Auditors.
