The European Parliament adopted a resolution drafted by Hans-Peter MAYER (EPP-ED, DE) by 563 votes in favour to 19 against and approved the proposal for a directive of the European Parliament and of the Council relating to the roll-over protection structures of wheeled agricultural or forestry tractors (codified version)

PURPOSE: to codify legislation on the roll-over protection structures of wheeled agricultural or forestry tractors.

PROPOSED ACT: Directive of the European Parliament and of the Council.

CONTENT: the purpose of this proposal is to undertake a codification of Council Directive 77/536/EEC of 28 June 1977 on the approximation of the laws of the Member States relating to the roll-over protection structures of wheeled agricultural or forestry tractors.
