## **Wheeled agricultural or forestry tractors: noise level (repeal. Directive 77/311/EEC). Codification**

2007/0205(COD) - 19/02/2008 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted a legislative resolution based on the report drafted by Francesco Enrico **SPERONI** (UEN, IT) approving, under the first reading of the codecision procedure, the proposal for a directive of the European Parliament and of the Council relating to the driver-perceived noise level of wheeled agricultural or forestry tractors (codified version).

## **Wheeled agricultural or forestry tractors: noise level (repeal. Directive 77/311/EEC). Codification**

2007/0205(COD) - 13/07/2009 - Final act

**PURPOSE:** to codify Council Directive 77/311/EEC relating to the driver-perceived noise level of wheeled agricultural or forestry tractors.

**LEGISLATIVE ACT:** Directive 2009/76/EC of the European Parliament and of the Council relating to the driver-perceived noise level of wheeled agricultural or forestry tractors.

**CONTENT:** Council Directive 77/311/EEC of 29 March 1977 on the approximation of the laws of the Member States relating to the driver-perceived noise level of wheeled agricultural or forestry tractors has been substantially amended several times. Thus, in the interests of clarity and rationality the Directive should be codified.

The new Directive will supersede the various acts incorporated in it. It fully preserves the content of the acts being codified and hence does no more than bring them together, with only such formal amendments as are required by the codification exercise itself.

**ENTRY INTO FORCE:** 21/08/2009.

**APPLICATION:** 01/01/2010.

## **Wheeled agricultural or forestry tractors: noise level (repeal. Directive 77/311/EEC). Codification**

2007/0205(COD) - 11/10/2007 - Legislative proposal

**PURPOSE:** to codify legislation relating to the driver-perceived noise level of wheeled agricultural or forestry tractors.

**PROPOSED ACT:** Directive of the European Parliament and of the Council.

**CONTENT:** the purpose of this proposal is to undertake the codification of Council Directive 77/311/EEC of 29 March 1977 on the approximation of the laws of the Member States relating to the driver-perceived noise level of wheeled agricultural or forestry tractors. The new Directive will supersede the various acts incorporated in it. This proposal fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.
