Court of Auditors: appointment of Michel Cretin

2007/0814(CNS) - 19/09/2007 - Legislative proposal

PURPOSE: to appoint a Member of the Court of Auditors.

PROPOSED ACT: Council Decision.

CONTENT: under Article 247, paragraph 3, of the EC Treaty and Article 160b of the EAEC, Members of the Court of Auditors are appointed by the Council, acting by a qualified majority after having consulted the European Parliament.

Given that the term of office of Mr Jean-François **BERNICOT** to the Court expires on 31 December 2007, the French authorities have proposed that Mr Michel **CRETIN** be his replacement.

As a consequence, this proposal aims to inform the European Parliament about the appointment of Mr Michel **CRETIN**.

Court of Auditors: appointment of Michel Cretin

2007/0814(CNS) - 10/12/2007

PURPOSE: appointment of Mr CRETIN as a member of the Court of Auditors.

LEGISLATIVE ACT: Council Decision 2008/41/EC, Euratom appointing seven members of the Court of Auditors.

CONTENT: The Council approves the appointment of Mr Michel CRETIN (France) as a member of the Court of Auditors (replacing Mr Jean-François BERNICOT).

His term of office will cover the period running from 1 January 2008 to 31 December 2013.

2007/0814(CNS) - 29/11/2007 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted the report by Inés **AYALA SENDER** (PES, ES) by 564 votes for, 28 against and 39 abstentions, and delivered a favourable opinion on the nomination of Michel **CRETIN** (France) as a Member of the Court of Auditors.
