## Court of Auditors: appointment of Ioannis Sarmas

2007/0818(CNS) - 29/11/2007 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted the report by Inés **AYALA SENDER** (PES, ES) by 568 votes for, 29 against and 39 abstentions, and delivered a favourable opinion on the nomination of Ioannis **SARMAS** (Greece) as a Member of the Court of Auditors.

## Court of Auditors: appointment of Ioannis Sarmas

2007/0818(CNS) - 19/09/2007 - Legislative proposal

PURPOSE: to appoint a Member of the Court of Auditors.

PROPOSED ACT: Council Decision.

CONTENT: under Article 247, paragraph 3, of the EC Treaty and Article 160b of the EAEC, Members of the Court of Auditors are appointed by the Council, acting by a qualified majority after having consulted the European Parliament.

Given that the term of office of Mr Ioannis **SARMAS** to the Court expires on 31 December 2007, the Greek authorities have proposed for his term of office to be renewed.

As a consequence, this proposal aims to inform the European Parliament about the appointment of Mr Ioannis **SARMAS**.

## **Court of Auditors: appointment of Ioannis Sarmas**

2007/0818(CNS) - 10/12/2007

PURPOSE: appointment of Mr SARMAS as member of the Court of Auditors.

LEGISLATIVE ACT: Council Decision 2008/41/EC, Euratom appointing seven members of the Court of Auditors.

CONTENT: The Council approves the appointment of Mr Ioannis SARMAS (Greece) as a member of the Court of Auditors (renewal of mandate).

His term of office will cover the period running from 1 January 2008 to 31 December 2013.
