Inland waterways vessels: reciprocal recognition of navigability licences. Codification

2008/0021(COD) - 30/01/2008 - Legislative proposal

PURPOSE: codification of Directive 76/135/EEC on the reciprocal recognition of navigability licences for inland waterway vessels.

PROPOSED ACT: Directive of the European Parliament and of the Council.

CONTENT: the purpose of this proposal is to undertake a codification of Council Directive 76/135/EEC, of 20 January 1976, on the reciprocal recognition of navigability licences for inland waterway vessels.

The new Directive will supersede the various acts incorporated in it; this proposal fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.

2008/0021(COD) - 17/06/2008 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted, by 639 votes to 10 with 10 abstentions, a legislative resolution approving, under 1st reading of the codecision procedure, the proposal for a directive of the European Parliament and of the Council on reciprocal recognition of navigability licences for inland waterway vessels (codified version).

The report had been tabled for consideration in plenary by Lidia Joanna **GERINGER de OEDENBERG** (PES, PL) on behalf of the Committee on Legal Affairs.

The proposal is approved as adapted to the recommendations of the Consultative Working Party of the Legal Services of the European Parliament, the Council and the Commission.

2008/0021(COD) - 16/09/2009 - Final act

PURPOSE: codification of Directive 76/135/EEC on the reciprocal recognition of navigability licences for inland waterway vessels.

LEGISLATIVE ACT: Directive 2009/100/EC of the European Parliament and of the Council on reciprocal recognition of navigability licences for inland waterway vessels (codified version).

CONTENT: the purpose of this Directive is to undertake a codification of Council Directive 76/135/EEC, of 20 January 1976, on the reciprocal recognition of navigability licences for inland waterway vessels.

The new Directive will supersede the various acts incorporated in it. It fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.
