Road safety: statutory markings for two- or three-wheel motor vehicles. Codification

2008/0099(COD) - 25/11/2009 - Final act

PURPOSE: to codify Directive 93/34/EC on provisions on statutory marking for two- or three-wheel motor vehicles.

LEGISLATIVE ACT: Directive 2009/139/EC of the European Parliament and of the Council on statutory markings for two- or three-wheel motor vehicles (codified version).

CONTENT: the purpose of this directive is to codify Council Directive 93/34/EC of 14 June 1993 on EU provisions on statutory markings for two- or three-wheel motor vehicles. The new Directive will supersede the various acts incorporated in it. It fully preserves the content of the acts being codified and hence does no more than bring them together, with only such formal amendments as are required by the codification exercise itself.

ENTRY INTO FORCE: 29/12/2009.

APPLICATION: from 01/06/2010.

Road safety: statutory markings for two- or three-wheel motor vehicles. Codification

2008/0099(COD) - 18/11/2008 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted, by 617 votes to 17 with 16 abstentions, a legislative resolution following 1st reading of codecision procedure, and approved the proposal for a directive of the European Parliament and of the Council on statutory markings for two- or three-wheel motor vehicles (codified version). The report had been tabled for consideration in plenary by Diana WALLIS (ADLE, UK) on behalf of the Legal Affairs Committee.

The Commission proposal is approved as adapted to the recommendations of the Consultative Working Party of the legal services of the European Parliament, the Council and the Commission.

2008/0099(COD) - 26/05/2008 - Legislative proposal

PURPOSE: to codify provisions on statutory marking for two- or three-wheel motor vehicles.

PROPOSED ACT: Directive of the European Parliament and of the Council.

CONTENT: the purpose of this proposal is to codify EU provisions on statutory markings for two- or three-wheel motor vehicles. In codifying legislative acts that have been amended frequently the EU is seeking to both simplify and clarify EU legislation.

The new Directive will supersede the various acts incorporated in it. It fully preserves the content of the acts being codified and hence does no more than bring them together, with only such formal amendments as are required by the codification exercise itself.
