Company law on single-member private limited liability companies. Codification

2008/0109(COD) - 09/06/2008 - Legislative proposal

PURPOSE: to codify provisions in the area of company law on single-member private limited-liability companies.

PROPOSED ACT: Directive of the European Parliament and of the Council.

CONTENT: the purpose of this proposal is to codify EU provisions on in the area of company law on single-member private limited-liability companies. In codifying legislative acts that have been amended frequently the EU is seeking to both simplify and clarify EU legislation. The new Directive will supersede the various acts incorporated in it. It fully preserves the content of the acts being codified and hence does no more than bring them together, with only such formal amendments as are required by the codification exercise itself.

Company law on single-member private limited liability companies. Codification

2008/0109(COD) - 18/11/2008 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted, by 631 votes to 17 with 12 abstentions, a legislative resolution, following 1st reading of codecision procedure, and approved the proposal for a directive of the European Parliament and of the Council in the area of company law on single-member private limited-liability companies (codified version). The report had been tabled for consideration in plenary by Diana **WALLIS** (ADLE, UK) on behalf of the Legal Affairs Committee.

The Commission proposal is approved as adapted to the recommendations of the Consultative Working Party of the legal services of the European Parliament, the Council and the Commission.

Company law on single-member private limited liability companies. Codification

2008/0109(COD) - 16/09/2009 - Final act

PURPOSE: to codify provisions in the area of company law on single-member private limited-liability companies.

LEGISLATIVE ACT: Directive 2009/102/EC of the European Parliament and of the Council in the area of company law on single-member private limited liability companies (codified version).

CONTENT: the purpose of this Directive is to undertake a codification of Twelfth Council Company Law Directive 89/667/EEC of 21 December 1989 on single-member private limited-liability companies. This new Directive will supersede the various acts incorporated in it. The Directive fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.

ENTRY INTO FORCE: 21/10/2009.
