Community system of reliefs from customs duty. Codification

2008/0235(CNS) - 11/12/2008 - Legislative proposal

PURPOSE: to codify legislation as regards the setting up a Community system of reliefs from customs duty.

PROPOSED ACT: Council Regulation.

CONTENT: the purpose of this proposal is to undertake a codification of Council Regulation (EEC) No 918/83 of 28 March 1983 setting up a Community system of reliefs from customs duty. The new Regulation will supersede the various acts incorporated in it. This proposal fully preserves the content of the acts being codified and hence does no more than bringing them together with only such formal amendments as are required by the codification exercise itself.

Community system of reliefs from customs duty. Codification

2008/0235(CNS) - 24/03/2009 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted by 566 votes to 5, with 7 abstentions, a legislative resolution approving unamended, under the consultation procedure, the proposal for a Council regulation setting up a Community system of reliefs from customs duty (codified version).

The Commission proposal was approved as adapted to the recommendations of the Consultative Working Party of the Legal Services of the European Parliament, the Council and the Commission.

2008/0235(CNS) - 16/11/2009 - Final act

PURPOSE: codification of Council Regulation (EEC) n° 918/83 setting up a Community system of reliefs from customs duty.

LEGISLATIVE ACT: Council Regulation (EC) No 1186/2009 setting up a Community system of reliefs from customs duty (codified version).

CONTENT: the purpose of this Regulation is to undertake a codification of Council Regulation (EEC) No 918/83 setting up a Community system of reliefs from customs duty. The new Regulation will supersede the various acts incorporated in it. It fully preserves the content of the acts being codified and hence does no more than bringing them together with only such formal amendments as are required by the codification exercise itself.

ENTRY INTO FORCE: 30/12/2009. The Regulation will apply from 01/01/2010.
