## Decision approving the appointment of Antonio Tajani as a Member of the Commission

2008/2141(INS) - 09/05/2008 - Final act

PURPOSE: to appoint Mr Antonio TAJANI to be a member of the European Commission.

LEGISLATIVE ACT : Council Decision 2008/380/EC, Euratom appointing a new member of the Commission of the European Communities

CONTENT: this Decision appoints **Mr Antonio TAJANI** to be a member of the European Commission for the period from 9 May 2008 to 31 October 2009. His appointment follows the resignation from the Commission of Mr Franco FRATTINI in a letter dated 7 May 2008, followed by a letter dated 8 May 2008.

DATE OF EFFECT: 09/05/2008.

## Decision approving the appointment of Antonio Tajani as a Member of the Commission

2008/2141(INS) - 18/06/2008 - Text adopted by Parliament, topical subjects

The European Parliament adopted, by 507 votes to 53 and 64 abstentions, a Decision approving the appointment of Mr Antonio **TAJANI** as a Member of the Commission for the remainder of the Commission's term of office until 31 October 2009.
