## Trans-European networks: granting of Community financial aid. Codification

2009/0037(COD) - 30/11/2009 - Final act

PURPOSE: to codify Council Regulation (EC) No 2236/95 of 18 September 1995 laying down general rules for the granting of Community financial aid in the field of trans-European networks.

LEGISLATIVE ACT: Regulation (EC) No 67/2010 of the European Parliament and of the Council laying down general rules for the granting of Community financial aid in the field of trans-European networks (codified version).

CONTENT: the purpose of this Regulation is to undertake a codification of Council Regulation (EC) No 2236/95 of 18 September 1995 laying down general rules for the granting of Community financial aid in the field of trans-European networks. The new Regulation supersedes the various acts incorporated in it. Accordingly, it fully preserves the content of the acts being codified and hence does no more than bring them together with only such formal amendments as are required by the codification exercise itself.

ENTRY INTO FORCE: 19/02/2010.

## Trans-European networks: granting of Community financial aid. Codification

2009/0037(COD) - 24/11/2009 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted by 584 votes to 24 with 1 abstention, a legislative resolution approving, under the first reading of the codecision procedure, the proposal for a regulation of the European Parliament and of the Council laying down general rules for the granting of Community financial aid in the field of trans-European networks (codified version).

The Commission's proposal was approved as adapted to the recommendations of the Consultative Working Party of the legal services of the European Parliament, the Council and the Commission.
