EU/Iraq Partnership and Cooperation Agreement

2010/0310(NLE) - 11/12/2012 - Committee report tabled for plenary, 1st reading/single reading

The Committee on Foreign Affairs adopted the report by Mario MAURO (EPP, IT) in which it recommends the European Parliament to give its consent to the conclusion of a Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Republic of Iraq, of the other part.

Overall, Members welcomed the agreement which will enable Iraq to maintain its stability, by supporting its democratic and pluralist institutions as well as through continuous technical assistance to secure the sustainability and efficiency of the Iraqi economy.

EU/Iraq Partnership and Cooperation Agreement

2010/0310(NLE) - 17/01/2013 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted a legislative resolution on the draft Council decision on the conclusion of a Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Republic of Iraq, of the other part.

CONTENT: the draft EU-Iraq Partnership and Cooperation Agreement provides a **legal framework** covering issues from regular political dialogue to trade relations and regulatory cooperation, and development assistance.

EU/Iraq Partnership and Cooperation Agreement

2010/0310(NLE) - 26/06/2018 - Committee final report tabled for plenary, reconsultation

The Committee on Foreign Affairs adopted the report by Tokia SAÏFI (EPP, FR) on the draft Council decision on the conclusion of a Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Republic of Iraq, of the other part.

The committee recommended that Parliament **give its consent** to conclusion of the Agreement.

It also adopted an own-initiative report containing a [non-legislative motion for a resolution](#) on the draft Council decision.

The draft EU-Iraq Partnership and Cooperation Agreement provides a legal framework covering issues from regular political dialogue to trade relations and regulatory cooperation, and development assistance. Its aim is to build a solid basis for strengthening ties between Iraq and the EU.

The Agreement underlines the EU's determination to play a significant role in Iraq's transition and will be the main vehicle for the EU's support to Iraq and further enhancement of EU-Iraq relations.

EU/Iraq Partnership and Cooperation Agreement

2010/0310(NLE) - 20/07/2018 - Final act

PURPOSE: to approve, on behalf of the Union, a Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Republic of Iraq, of the other part.

NON-LEGISLATIVE ACT: Council Decision (EU) 2018/1107 on the conclusion of a Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Republic of Iraq, of the other part.

CONTENT: the Council decided to approve, on behalf of the Union, **the Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Republic of Iraq**, of the other part, together with the Annexes and the declaration made unilaterally, attached to the Final Act.

The Partnership Agreement was signed on 11 May 2012 subject to its possible conclusion at a later date.

Concluded for a period of **10 years** (renewable), the agreement is intended to provide a solid basis for strengthening ties between Iraq and the EU. In particular, it aims to enhance political dialogue on bilateral, regional and global issues by improving trade regimes between Iraq and the EU, supporting Iraq's key development and reform efforts and facilitating its integration into the wider international economy.

The agreement is based on respect for democratic principles and human rights and the principles of the rule of law. Its objectives are:

- to establish a **regular political dialogue** between the parties with the aim of strengthening their relations, contributing to the development of a partnership and increasing mutual understanding and solidarity. In the field of foreign and security policy cooperation, the Parties undertake to: (i) cooperate in order to prevent and eliminate terrorist acts; (ii) contribute to the fight against the proliferation of weapons of mass destruction; and (iii) examine the possibility of Iraq's future accession to the Rome Statute of the International Criminal Court;
- to promote **trade and investment** and the development of harmonious economic relations between the Parties and thereby foster their sustainable economic development. The trade section introduces a dispute settlement mechanism providing for the binding force of arbitration panel decisions and compliance procedures.
- to provide a basis for legislative, economic, social, financial and cultural **cooperation**.

Institutional provisions are laid down concerning the implementation of the Agreement and the establishment of a **Cooperation Council** meeting once a year at ministerial level and a Cooperation Committee to assist it in carrying out its duties.

ENTRY INTO FORCE: 20.7.2018.

EU/Iraq Partnership and Cooperation Agreement

2010/0310(NLE) - 04/07/2018 - Text adopted by Parliament after reconsultation

The European Parliament adopted, by 565 votes to 75, with 34 abstentions, a legislative resolution on the draft Council decision on the conclusion of a Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and the Republic of Iraq, of the other part.

Parliament **gave its consent** to the conclusion of the agreement. It also adopted a [non-legislative resolution](#) on the draft Council decision.

The draft EU-Iraq Partnership and Cooperation Agreement provides a legal framework covering issues from regular political dialogue to trade relations and regulatory cooperation, and development assistance. Its aim is to build a solid basis for strengthening ties between Iraq and the EU.

EU/Iraq Partnership and Cooperation Agreement

2010/0310(NLE) - 29/01/2018 - Amended legislative proposal for reconsultation

The Council decided to consult the European Parliament again on its draft decision on the conclusion of a Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and Iraq, of the other part.

The Partnership and Cooperation Agreement between the European Union and its Member States, of the one part, and Iraq, of the other part, was signed on 11 May 2012 subject to its possible conclusion at a later date. The Agreement must now be approved.

The Council may adopt the act only if the European Parliament gives it consent to it.
