2010/0811(NLE) - 26/04/2010 - Final act

PURPOSE: to appoint a member of the Court of Auditors.

LEGISLATIVE ACT: Council Decision 2010/246/EU appointing nine members of the Court of Auditors.

CONTENT: under this Decision, Mr Ladislav BALKO is appointed member of the Court of Auditors for the period from 7 May 2010 to 6 May 2016.

The European Parliament adopted by 556 votes to 11 with 52 abstentions a decision delivering a favourable opinion on the nomination of Ladislav Balko (SK) a Member of the Court of Auditors.
