2010/0812(NLE) - 31/03/2010 - Final act

PURPOSE: to appoint Mr Eoin O'Shea as a member of the Court of Auditors until 29 February 2012.

LEGISLATIVE ACT: Council Decision 2010/251/EU appointing a member of the Court of Auditors.

CONTENT: following the resignation of Máire Geoghegan-Quinn as Member of the Court of Auditors by letter of 8 February 2010, this Decision appoints Mr Eoin O'SHEA a member of the Court of Auditors for the remainder of the term of office of Ms Máire GEOGHEGAN-QUINN, which runs until 29 February 2012.

ENTRY INTO FORCE: 31/03/2010.

The European Parliament adopted by 573 votes to 6 with 51 abstentions a decision delivering a favourable opinion on the nomination of Eoin O'Shea (IE) as a Member of the Court of Auditors.
