2010/0819(NLE) - 07/10/2010 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted by 535 votes to 21 with 45 abstentions a decision delivering a favourable opinion on the nomination of Gijs de Vries (NL) as a Member of the Court of Auditors.

PURPOSE: to appoint a member of the Court of Auditors.

LEGISLATIVE ACT: Council Decision 2010/696/EC appointing a member of the Court of Auditors.

CONTENT: Mr Maarten B. ENGWIRDA, member of the Court of Auditors, has resigned with effect from 1 January 2011. The Council has decided to appoint Mr Gijs M. de VRIES as his replacement as a member of the Court of Auditors for the period from 1 January 2011 to 31 December 2013.
