European Central Bank (ECB): appointment of Peter Praet as member of the Executive Board, 1 June 2011

2011/0802(NLE) - 25/03/2011 - Final act

PURPOSE: to appoint Peter Praet as a member of the Executive Board of the ECB.

NON-LEGISLATIVE ACT: European Council Decision 2011/195/EU appointing a member of the Executive Board of the European Central Bank.

CONTENT: the European Council adopted this Decision appointing Peter PRAET (BE) as a member of the Executive Board of the European Central Bank for a term of office of 8 years, as from 1 June 2011.

ENTRY INTO FORCE: 25/03/2011.

European Central Bank (ECB): appointment of Peter Praet as member of the Executive Board, 1 June 2011

2011/0802(NLE) - 24/03/2011 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted by 526 votes to 37, with 71 abstentions, a decision in which it delivers a favourable opinion to the European Council on the Council recommendation to appoint Peter PRAET (BE) as a member of the Executive Board of the European Central Bank.
