## Court of Auditors: appointment of a member, H.G. Wessberg - SE

2011/0807(NLE) - 28/11/2011 - Committee report tabled for plenary, 1st reading/single reading

The Committee on Budgetary Control adopted the report drafted by Inés AYALA SENDER (S&D, ES) in which it calls on the European Parliament to deliver a favourable opinion on the Council's nomination of **Hans Gustaf Wessberg** (SE) as a Member of the Court of Auditors. Hans Gustaf Wessberg fulfils the conditions laid down in Article 286(1) of the Treaty on the Functioning of the EU (TFEU).
