2011/0809(NLE) - 28/11/2011 - Committee report tabled for plenary, 1st reading/single reading

The Committee on Budgetary Control adopted the report drafted by Inés AYALA SENDER (S&D, ES) in which it calls on the European Parliament to deliver a favourable opinion on the Council's nomination of **Vítor Manuel da Silva Caldeira** (PT) as a Member of the Court of Auditors. Vítor Manuel da Silva Caldeira fulfils the conditions laid down in Article 286(1) of the Treaty on the Functioning of the EU (TFEU).
