EU/Armenia framework agreement: general principles for the participation of Armenia in Union programmes. Protocol to the EC/Armenia Partnership and Cooperation Agreement

2012/0247(NLE) - 20/02/2014 - Final act

PURPOSE: the conclusion of a Protocol to the Partnership and Cooperation Agreement between the European Communities and their Member States, of the one part, and the Republic of Armenia, of the other part, on a Framework Agreement between the European Union and the Republic of Armenia on the general principles for the participation of the Republic of Armenia in Union programmes.

NON-LEGISLATIVE ACT: Council Decision 2014/347/EU on the conclusion of a Protocol to the Partnership and Cooperation Agreement between the European Communities and their Member States, of the one part, and the Republic of Armenia, of the other part, on a Framework Agreement between the European Union and the Republic of Armenia on the general principles for the participation of the Republic of Armenia in Union programmes.

BACKGROUND: the Protocol to the Partnership and Cooperation Agreement between the European Communities and their Member States, of the one part, and the Republic of Armenia, of the other part, on a Framework Agreement between the European Union and the Republic of Armenia on the general principles for the participation of the Republic of Armenia in Union programmes was signed on behalf of the Union on 17 December 2012.

It is now appropriate to approve the protocol on behalf of the European Union.

CONTENT: by means of this Decision, the Council approves on behalf of the European Union, with the consent of the European Parliament, a Protocol containing a Framework Agreement on the general principles for the participation of the Republic of Armenia in Union programmes.

Main provisions: the Protocol sets down, in particular, the specific terms and conditions regarding the **participation of Armenia in each particular programme**, in particular **the financial contribution** payable and reporting and evaluation procedures which shall be determined in the context of an agreement between the European Commission, on behalf of the Union, and Armenia.

ENTRY INTO FORCE: 20.02.2014. The date of entry into force of the protocol will be published in the *Official Journal of the European Union* by the General Secretariat of the Council.

Based upon this Communication and those conclusions, the Council, on 18 June 2007, issued directives to the Commission to negotiate Framework Agreements with Algeria, **Armenia**, Azerbaijan, Egypt, Georgia, Israel, Jordan, Lebanon, Moldova, Morocco, the Palestinian Authority, Tunisia and Ukraine, on the general principles for their participation in Community programmes. A number of protocols were then signed with some of these countries.

In April 2012, Armenia expressed its interest to participate in the broad range of programmes open to partner countries of the European Neighbourhood Policy. The text of the Protocol negotiated with Armenia is the subject of this proposal and is attached in the annex. It is now appropriate to conclude this Protocol on behalf of the European Union.

IMPACT ASSESSMENT: no impact assessment was undertaken.

2012/0247(NLE) - 04/12/2012 - Legislative proposal

PURPOSE: to conclude a Protocol to the Partnership and Cooperation Agreement between the European Communities and their Member States, of the one part, and Armenia, of the other part, on a Framework Agreement between the European Union and Armenia on the general principles for the participation of Armenia in Union programmes.

PROPOSED ACT: Council Decision.

BACKGROUND: in accordance with a Council Decision, a new Protocol to the Partnership and Cooperation Agreement between the European Communities and their Member States, of the one part, and Armenia, of the other part, on a Framework Agreement between the European Union and Armenia on the general principles for the participation of Armenia in Union programmes was signed on behalf of the Union.

The Protocol should now be approved on behalf of the European Union.

LEGAL BASIS: Articles 114, 168, 169 and 172, Article 173(3), and Articles 188 and 192, in conjunction with Article 218(6)(a) of the Treaty on the Functioning of the European Union (TFEU).

CONTENT: **under this Council proposal**, it is proposed to approve, on behalf of the European Union, a draft Protocol to the Partnership and Cooperation Agreement between the European Communities and their Member States, of the one part, and Armenia, of the other part, on a Framework Agreement between the European Union and Armenia on the general principles for the participation of Armenia in Union programmes.

The specific terms and conditions regarding the participation of Armenia in each particular programme, in particular the financial contribution payable and reporting and evaluation procedures, shall be determined in a Memorandum of Understanding between the European Commission and the competent authorities of Armenia on the basis of the criteria established by the programmes concerned.

2012/0247(NLE) - 25/11/2013 - Committee report tabled for plenary, 1st reading/single reading

The Committee on Foreign Affairs adopted the report by Tomasz Piotr POREBA (ECR, PL) on the draft Council decision on the conclusion of a Protocol to the Partnership and Cooperation Agreement between the European Communities and their Member States, of the one part, and the Republic of Armenia, of the other part, on a Framework Agreement between the European Union and the Republic of Armenia on the general principles for the participation of the Republic of Armenia in Union programmes.

Members recommended the European Parliament to give its consent to the conclusion of the Protocol. They considered that this Protocol would **strengthen relations** with Armenia in order to promote further cultural, educational, environmental, technical and scientific links, enhancing people-to-people contacts and sectoral cooperation, as well as strengthening the political and relations through the Eastern Partnership and the Association Agreement.
