2012/0801(NLE) - 14/02/2012 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted, by secret ballot, by 310 votes to 276, with 87 abstentions, a decision approving the appointment of Baudilio Tomé Muguruza (ES) as a Member of the Court of Auditors.

PURPOSE: appointment of a Member of the Court of Auditors.

NON-LEGISLATIVE ACT: Council Decision 2012/125/EU appointing a Member of the Court of Auditors.

CONTENT: following the expiry of the term of office of Mr Juan RAMALLO MASSANET as a Member of the Court of Auditors, on 29 February 2012, the Council decided to appoint Mr Baudilio TOMÉ MUGURUZA as Member of the Court of Auditors to take his place for the period from 1 March 2012 to 28 February 2018.
