Court of Auditors: appointment of a member, Neven Mates (Croatia)

2013/0804(NLE) - 29/05/2013 - Committee report tabled for plenary, 1st reading/single reading

The Committee on Budgetary Control adopted the report drafted by Inés AYALA SENDER (S&D, ES) in which it calls on the European Parliament to deliver a negative opinion on the Council's nomination of **Neven MATES** (HR) as a Member of the Court of Auditors. The committee advises Parliament against endorsing Neven MATES's candidacy for this post.

Court of Auditors: appointment of a member, Neven Mates (Croatia)

2013/0804(NLE) - 12/06/2013 - Text adopted by Parliament, 1st reading/single reading

The European Parliament delivered a negative opinion on the Council's nomination of **Neven MATES** (HR) as a Member of the Court of Auditors. Mr MATES's appointment was rejected by 396 votes to 231, with 45 abstentions.

To recap, Mr MATES was evaluated by the competent parliamentary committee in accordance with Article 286(2). Following his hearing, the committee in question concluded his credentials were inappropriate for the post.

PURPOSE: to appoint a member of the Court of Auditors.

NON-LEGISLATIVE ACT: Council Decision 2013/374/EU appointing a member of the Court of Auditors.

CONTENT: following the accession of Croatia to the European Union, the Council decided to appoint **Mr Neven MATES** (HR) as a member of the Court of Auditors for a term of office of six years, from 15 July 2013 to 14 July 2019. It should be noted that Parliament had delivered a negative opinion of this appointment.

ENTRY INTO FORCE: 09/07/2013.
