2013/0805(NLE) - 29/05/2013 - Committee report tabled for plenary, single reading

The Committee on Budgetary Control adopted the report drafted by Inés AYALA SENDER (S&D, ES) in which it calls on the European Parliament to deliver a favourable opinion on the Council's nomination of **George PUFAN** (RO) as a Member of the Court of Auditors. George PUFAN fulfils the conditions laid down in Article 286(1) of the Treaty on the Functioning of the EU (TFEU).

2013/0805(NLE) - 12/06/2013 - Text adopted by Parliament, 1st reading/single reading

The European Parliament delivered a favourable opinion on the Council's nomination of **George PUFAN** (RO) as a Member of the Court of Auditors with 334 votes in favour, 290 against and 48 abstentions.

George PUFAN fulfils the conditions laid down in Article 286(1) of the Treaty on the Functioning of the EU (TFEU).

PURPOSE: to appoint a member of the Court of Auditors.

NON-LEGISLATIVE ACT: Council Decision 2013/626/EU appointing a member of the Court of Auditors.

CONTENT: the term of office of Mr Ovidiu ISPIR is due to expire on 30 June 2013. The Council decided to appoint **Mr George PUFAN (RO)** to replace Mr ISPIR as a member of the Court of Auditors for the period from 1 July 2013 to 30 June 2019.

ENTRY INTO FORCE: 25/06/2013.
